PRACTISING CERTIFICATES AND THE HPCA ACT 2003

The principal purpose of the HPCA Act is to *“protect the health and safety of members of the public by providing for mechanisms to ensure that health practitioners are competent and fit to practise their professions”*. You are applying for a practising certificate under the HPCA Act 2003 – Section 26(1) (for annual practising certificates) or Section 31(1) (for interim practising certificates). If you are renewing a practising certificate, you will be treated as a holder of your new practising certificate from the date when the Board receives your completed application, including the correct fee payment, until the date it is issued or you are notified that it will not be issued.

Section 7(2) of the HPCA Act 2003 states that *“no person may claim to be practising a profession as a health practitioner of a particular kind or state or do anything that is calculated to suggest that the person practises or is willing to practise a profession as a health practitioner unless the person is a health practitioner of that kind; and holds a current practising certificate as a health practitioner of that kind.”*

IMPORTANT INFORMATION FOR PRACTISING CERTIFICATE APPLICANTS

The Board's Registrar will consider whether an application for a practising certificate should be declined or if conditions should be included in a psychologist's scope of practice where the Registrar believes on reasonable grounds that:

- (a) The applicant has, at any time, failed to maintain the required standard of competence; or
- (b) The applicant has failed to fulfil or has failed to comply with a condition included in their scope of practice; or
- (c) The applicant has not satisfactorily completed the requirements of any competence programme that he or she has been ordered by the Board to complete; or
- (d) The applicant has not held an annual practising certificate of a kind sought by the application within the three years immediately preceding the date of the application; or
- (e) The applicant is unable to perform the functions required for the profession because of some mental or physical condition; or
- (f) The applicant has not, within the three years immediately preceding the date of application, lawfully practised the profession to which the application relates; or
- (g) Any information included in the application is false or misleading.

NOTE: The Registrar may decline to issue a practising certificate until any outstanding fines, expenses, or costs owing to the Board are paid.

Application by a registered psychologist for a practising certificate for a period of three months (or less) and who has not been practising at any other time during that financial year	\$656.00 ¹
Application by a practitioner currently registered in the Intern Psychologist scope for an interim practising certificate (This fee may be reduced or waived for current IPC holders)	\$200.00
Application by a practitioner currently registered in the Trainee Psychologist scope for an interim practising certificate	\$856.00 ¹

¹ Note this fee includes the compulsory disciplinary levy of \$456 per annum.
